Treasurer's Report:

Unfinished Business:

Bro Josh Williams-Como reminded the Worshipful Master of the motions from previous meetings which he had tabled regarding the departure of our beloved WB DJ Gialanella. WB Moorhead advised of ongoing investigations, but that further study will be necessary. Several brothers offered alternate suggestions, including the "Hyde-Away". It was suggested that we may need to prepare some meals on our own until a suitable replacement caterer can be found. The Worshipful Master then advised that he imposes a \$150 budget per meeting on future meals and gaveled to discussion.
