Petitions:

Ballots:

With the ballot, being clear in the South, West and East, the Worshipful Master declared Bro Cole Farrand's petition for membership approved.

Bro Farrand was invited back into the lodge and congratulated on his acceptance into the lodge.

REPORTS

Treasurer's Report:

Bro Treasurer reported that the current balance of our main operating account stands at \$6,421.80 and our investment account at \$368,655.90.

Bro Secretary provided an update on the progress of 2025 dues collection from the brethren. Reminder notices went out via email on 6/1 to those that have not yet paid. All tolled, (29) of (96) members have yet to remit their 2025 Dues, thereby denying the lodge of funds needed to operate and maintain the lodge building.

Buildings & Grounds:

Bro Dugan advised:

- 1. The lodge room lighting project is being managed by WB Dan Kaufman and is planned to be executed over the summer.
- 2. He thanked Bro George for providing flowers and maintaining the planters outside the banquet room.
- 3. The downspout repair is to be done by our current landscaping contractor within the next couple of weeks.

Charity:

Bro Dugan advised that the last Bread of Life event was successful. It consisted of a bagged lunch, due to access limitations to the Church facilities. There was a lot of preparation in advance required, but there was sufficient help. However the cost of food purchases was approximately \$500, which depletes most of the funds set aside for BOL. He requested donations to replenish the funds.

The next BOL event is scheduled for Saturday 6/26. Assistance is needed in both prep/distributing the meals and food donations.

Rental Report:

WB Matt Kaufman reported that there has been several recent rental inquiries. There is one rental in June and one in July (wedding on 7/26).

Unfinished Business:

The Worshipful Master is looking to schedule the delivery/presentation of the plaque of appreciation to Bob Sheridan (owner of Sheridan' Lodge) for his support for the Bread of Life event. Bro Dugan suggested it be done on Friday 6/13 to allow any brothers that want to participate the opportunity to do so.

Bro Woldt inquired about the status of the previously planned Chicken BBQ fundraiser event. The Worshipful Master advised that due to several other potential conflicts with other events in September, the event will likely be abandoned. No further action at this time.

RW Eric Grove provided an update on the planned Washington DC bus trip. He noted that due to a lack interest, the event will be cancelled for this year. He advised that we will attempt again next year.

New Business:

The Worshipful Master advised that the OES has requested to hold there 6/23 meeting at Harmony Lodge, due to conflict with the DLI picnic at Kittatinny #164 the same evening. He granted their request and asked that it be put on the event calendar.

Program:

As this evening had been scheduled to be a Gold Token night and Official Visit, the RW Dwayne Dolly, DDGM was present. However, as none of the honorees could attend, the prior was cancelled. Instead, the Worshipful Master requested and received dispensation to host a "Hawaiian shirt" night this evening. All brethren present adorned their best Hawaiian shirts (including the DDGM) and "Aloha" was a frequent response.
