Merger and consolidation:

The letter of proposal of consolidation was read to the brethren again by WB Roberts. The instructions on how to vote were addressed. ¾ written vote with a judge and 2 tellers, every member present must vote. Write YES if for, write NO if against, any other writings on the ballot will invalidate the ballot.

Motion to move forward with consolidation was made by WB Roberts, 2nd by WB Johnson. Discussion:

WB Tom Smith called to delay for 2 months, had not known anything about the consolidation until the summons. Discussed other traditions where those must be asked to help and will never reach out to the master on their own. Not at all in favor of merging with Mozart Loge, changing the day of the meeting or the name of the lodge. RW Choyinski said we joined a fraternity, not a lodge and that bringing in Mozart Lodge is not a bad thing. WB Roberts expressed his feelings on the matter as the chair of the committee and the dire straits that the officer line is currently in and that without a change, there will not be a lodge at all very soon. Eveny month we express the need for help in the trestleboard with no response, except for one time, when a brother asked what he could do, was given the Ladie's night event to organize people for, and when he discovered that the same people every day are the only ones doing things, sent a letter of demit, which was ready at the beginning of this meeting, that was Bro Jeffrey Pennel. Things are not getting better, delaying it will make it worse. At least we have the option to do things on our terms now, rather than Grand Lodge stepping in and making things happen on their terms, or worse, shutting the lodge down.

WB Johnson expressed his feelings as a committee member, and how in 2018 while he was master, there was a change where we could tell then things needed to change. We have poor attendance at lodge meetings, events, and we're falling apart. The consolidation was well thought out and researched.

Bro Alex Perry, WB Tom Smith and Bro Mark Valentin, DB Stephen Callaghan all expressed that they would like to see this tabled for 2 months to meet the brothers of Mozart, get information on their financials and see what we can do to make it a better situation.

WM stated that we have had events in conjunction with Mozart Lodge throughout the year which were opportunities to meet these brothers, which were all announced in the trestleboards.

WB Roberts then withdrew his motion. Delaying until November pushes it past the Grand Lodge Annual, and it needs to be done prior to that to be completed for 2026. Would recommend doing this in October. Also leaves time to decide if the warrant may need to be surrendered.

A motion was made by DB Rosario, 2nd by WB Martinez to table the vote until the October meeting. 18 for 3 against.

October's meeting will be October 9th, 2025 at 7:30pm and we will have dinner prior, at 6:30. WM expressed that DLI is on October 8th and they can come meet the members of Mozart then if not before. Mozart also meets every month on the 1st Tuesdays at 7:30, dinner always at 6:30.
