The Secretary advised that the lodge received the formal request to demit from Bro Johannes DeWaal. With it he paid his 2024 dues in full and offer very kind words to the brethren. As required by the constitution, a manual sign vote was made, approving the request to demit.

## **Ballots:**

A motion was made to ballot collectively for the suspension for non-payment of dues, which was seconded and carried by the lodge.

The Worshipful Master spread the ballot for the suspension of the list of brethren presented by the Secretary for non-payment of dues. The ballot, being clear in the South, West and East, the Worshipful Master declared the list of brothers to be suspended for non-payment of dues, effective at midnight of December 31, 2024. He also advised that should any listed brother remit payment of dues prior to that deadline, the NPD vote will be automatically rescinded for that brother.

## REPORTS

# Treasurer's Report:

On behalf of the Treasurer and Worshipful Master, the Secretary offered the following financial updates-Account balances as of 11/21/24: BOL acct: 2799 - \$730.00 GLNJ acct: 2802 - \$6,862.00 Foundation acct: 2772 - \$234.00 Layton Scholarship acct: 2780 - \$184.00 Primary Operating acct: 2426 - \$10,111.47 \*After forecasted expenditures thru 12/31, we anticipate a remaining balance of approximately \$3,000.00 to begin the new year.

RW Eric Grove reported that the investment accounts are doing very well, that as of 11/20/24 our primary account was approximately \$329,000.00, up substantially for the year.

\*The Worshipful Master commented that this result was aided by the fact that we had budgeted needing to withdraw at least \$14k from that account but have only taken out a total of \$5k for the year.

A motion was made, seconded and carried to accept the Treasurer's report.

# **Buildings & Grounds:**

Bro Dugan took the opportunity to thank all those that have participated on the B&G committee and asked the Worshipful Master to comment on the status of the ongoing lodge lighting upgrade project. The Worshipful Master advised that conversion of the lodge lighting to LED is in progress, but not yet completed. The lighting has been upgraded in the kitchen, banquet room, Jimmy's Lounge, vestibule and the illuminated sign in front of the building. Some work still remains in these areas. Still to be done is lodge room, hallway and restrooms. He advised the intent to purchase the remaining materials necessary under the current year's budget.

# **Charity:**

The Worshipful Master advised that the Bread of Life charity is moving closer to finalizing all outstanding issues with the church. We are awaiting further guidance as to when we may resume activities in the church.

## **Rental Report:**

WB Matt Kaufman advised that there has been a steady amount of inquiries for rentals over that past month. We have booked one new rental in May and have a rental this coming weekend with Scouts USA Troop 1150.

### **Unfinished Business:**

The Worshipful Master put the lodge on a tiled refreshment to allow those present to make nominations for 2025 elected officers. After coming off refreshment, the Worshipful Master declared nominations closed. He appointed RW George Stypolkowski judge and Brothers Brown and Domingez as tellers.

### New Business:

RW George Stypolkowski addressed the lodge concerning the recently approved Grand Lodge legislation allowing blue lodges to accept long or short form proficiency exams for candidates. He advised that, although he is not endorsing one over the other, that it is this lodge's longstanding tradition to follow long form proficiency. The Worshipful Master agreed with this assertion.

The Worshipful Master opened a preliminary discussion on the topic of 2025 Annual Dues. It was his intention to begin a dialogue so as to work thru some of the questions or issues prior to the annual meeting where the dues are set for the year. With the current year's dues at \$220 and the GL assessment going up to \$76.00 per member for 2025, suggestions included \$250, \$300, even a dollar a day (\$365). However, it was noted that despite any dues amount selected, there are not restrictions on what a brother can donate. Anyone may donate as much as they want or can afford. However, it was also noted that with the loss of membership due to attrition and NPD, we will need to increase dues as much as possible.

The Worshipful Master offered comments on the topic of honorariums to be decided at the annual meeting. He stated that there had been stipends or other methods of compensation introduced in the past. However, he wanted to continue what was started last year. He advised that he would like to forgive the dues for the next Worshipful Master, Treasurer, Secretary, Rental Coordinator and Buildings & Grounds Chairman due to the huge investment of time each makes in the promoting the success of the lodge. Providing direct compensation to these brothers can present unwanted tax implications.

## Program:

The Worshipful Master presented an audio podcast from the Midnight Masons entitled "Obligations". It reminded us of why our masonic obligations are important in our daily lives and the hard truths about them.
