#### REPORTS

#### Treasurer's Report:

The Worshipful Master provided and update on behalf of the Treasurer. He advised that all expenses have been proceeding as planned and that we will be solvent thru the end of the year. Our budget remains ahead of what was forecast at the start of his term, due to actively working to minimize costs and better than expected rental business.

#### **Buildings & Grounds:**

Bro Dugan deferred this report to the Worshipful Master as he was the champion of recent efforts in the lodge. The Worshipful Master reported that the lighting upgrade project is ongoing. The current plan is to complete the pre-purchase of all necessary materials to complete the work. The lodge room effort will likely

occur over the summer but will need to be closely coordinated with any upcoming rental event. Additional electrical work in the kitchen area for new equipment should be completed very soon.

# Charity:

The Worshipful Master reported that we have received notice to resume our Bread of Life activities at the church. We were first notified just prior to Thanksgiving but were too close to the holiday to marshal the necessary support. We are now planning to resume on Saturday, December 28. There will be a gathering the evening before to prepare at the lodge. We request that any brothers and their families that wish to participate, do so and advise Bro Dave King (davek19662000@yahoo.com) who is coming and what, if anything, you may be bringing.

It was also suggested that we will welcome anyone willing to take the 12lb turkey from the lodge freezer home to cook and bring for the next event.

## **Rental Report:**

WB Matt Kaufman advised that there has been a steady flow of rental inquiries. He has a new contract in the works for February and is hoping to book a wedding over the summer.

## **Unfinished Business:**

Bro Ryan Carroll relayed thanks from Newton Rec Football for the generous donations to their recent event.

## New Business:

The Worshipful Master opened discussions as required at the Annual Communication for the following:

1. Lodge Dues for 2025:

The Worshipful Master called for suggestions, following up on this discussion from the last meeting. It was suggested that due to the Grand Lodge assessment increase to \$76.00 and the loss of members the past year, it would require and increase from \$220 overall to at least \$250 to make up for the increase and lost revenue. The Secretary advised that the 2024 Grand Lodge assessment is \$73.50. It was advised that the operating budget still has a shortfall in 2024 and will be projected to be in the red for 2025 as well. Although, the deficit was far less than anticipated, due to a much higher amount of rental income than expected and continuing efforts to minimize lodge expenses. Suggestions to raise annual dues included \$250, \$275, \$300 and \$365 (a dollar a day). The impact of an increase and the potential to lose members as a result, was discussed at length. It was also noted that despite the increase in dues that is set, there is no limitation on a brother contributing a greater amount.

A motion was made, seconded to raise the 2025 annual dues to \$300.00. The motion was carried.

2. 2025 Conferral Fee:

A motion was made and seconded to raise the conferral fee from \$550 to \$600 (twice the 2025 annual dues). The motion was carried.

#### 3. 2025 Honorariums:

A motion was made and seconded to forgive the 2025 annual dues for the Worshipful Master, Treasurer, Secretary, Rental Coordinator and Buildings & Grounds Committee Chair. This due to their extensive efforts to manage the affairs of the lodge. It was pointed out that, despite such forgiveness, several of the aforementioned officers will likely donate much more throughout the masonic year. The motion was carried. 4. Election of officers for the 2025 Masonic Year: The Worshipful Master appointed RW Eric Grove as Judge and Brothers Born and Carroll as tellers.

The nominations for the following positions were read and their responses noted-Worshipful Master – RW Fred Fox (accepted)- unopposed Senior Warden- Bro Stephen Dugan (accepted)- unopposed Junior Warden- WB Chris Bailey (accepted)- unopposed Secretary- Bro Barry George (accepted)- unopposed Treasurer- Bro Arjune Sharma (accepted)- unopposed Trustee- Bro Robert Woldt, DB (accepted)- unopposed Proxy to GL- Bro Curvey Purkett (accepted), Bro Carlos Torres (accepted), Bro Pat Harrison (accepted), Bro Chris Brown (accepted)

A motion was made and seconded that if there is but one candidate for a position, that a unanimous ballot be cast. The motion was carried. The Lodge was put on refreshment to allow the brethren to vote for the position of Proxy to GL.

The Worshipful Master called the lodge off refreshment and declared the ballot closed. The results for 2025 as follows-
